Outstanding Youth in Philanthropy

Founded and sponsored by Millennium Advantage

This award is presented to an individual age 16 to 22 years with a demonstrated history of philanthropic activity. The honoree will receive a \$1,000 scholarship and be able to direct a \$500 contribution to the charity of his/her choice. The award seeks to acknowledge a young person who has engaged in a variety of philanthropic activities, perhaps with more than one organization, rather than honoring a single achievement.

The award is intended to recognize a young adult who demonstrates:

Knowledge – evidence of an understanding of philanthropy and philanthropic fundraising.

Skills – evidence of ability to serve as a volunteer, evidence of ability to implement a community service project, evidence of ability to serve on a board or comparable advisory body, and evidence of ability to raise and donate money.

Attitude – recognizable commitment to volunteering for charitable organizations, raising funds and donating funds.

Values – willingness to share resources, to serve as a steward and to ask for volunteer and financial assistance for worthy causes.

The nomination should address the following:

- Description of the nominee's accomplishments including the time, talent and/or treasure given towards the project and the results achieved. Nomination should include goals, process, budget (if relevant), dollars raised, and others involved in the process (adults and other youth).
- Description of the impact the nominee has had on the community, including numbers of people involved, organizations helped, etc. Include the names and contact information of the benefiting organization or organizations.
- Long term impact of the nominee's work. How has the nominee demonstrated long term commitment/next steps to a specific project or ongoing projects?
- Evidence that nominee's accomplishments can serve as a prototype for others or is easily replicable in other communities.

Letters:

Letters of support from supervisors, mentors, teachers, etc. are not mandatory but are strongly encouraged. The letters should provide depth to the application but not introduce new information. Letters of support should be limited to three letters.

Please include a brief, personal statement from the nominee on his/her philanthropic philosophy.
